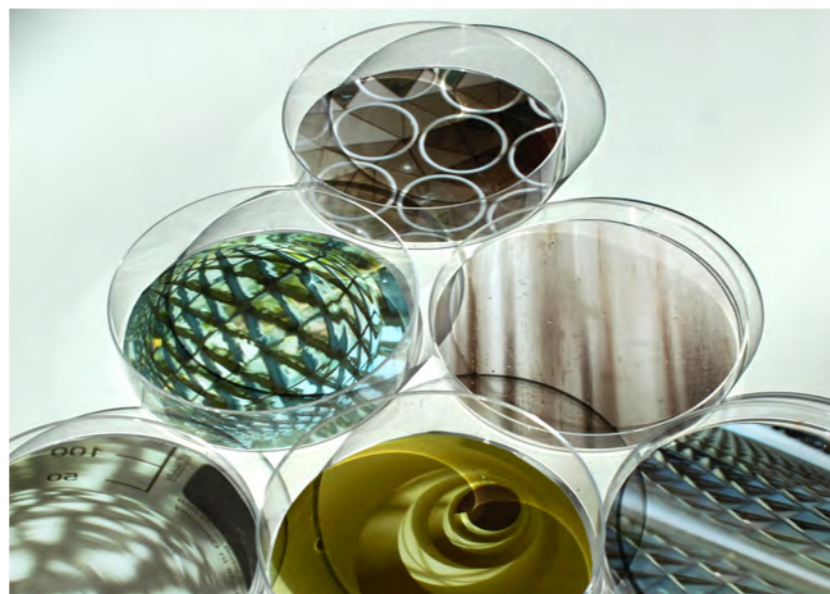

From 2021, researchers from around the world will travel to South Australia to collaborate with UniSA's research leaders. Together, they will have in their sights the big issues – from COVID-19 to child protection, from mental health to information security, and from user-friendly design to economic transformation. As well as finding solutions to complex issues we face as a global society, their discoveries will help our local businesses, communities and society to grow and prosper.

When researchers work alone, they produce great outcomes. When researchers collaborate and combine their exceptional talents, remarkable outcomes are achieved.

In 2021, the UniSA Visiting Research Fellowships scheme will commence

We will invite Fellows from top 100-ranked institutions worldwide to join us at UniSA. We will also invite Australian Aboriginal, Torres Strait Islander and Indigenous researchers, and researchers from DFAT-aid assisted countries. We want to invest in truly global partnership for change.

The residency of each Fellowship will last for a month and will attract a stipend of **\$15,000 AUD**, for flights, accommodation and incidentals to meet the costs of administering the scheme, materials and access to our research facilities, and public events.

The Fellows will work in collaboration with UniSA's researchers to generate ideas, papers, grants, and practices designed to support local and global business and community health and growth.

For every donation of \$15,000 to allow a single researcher visit, the UniSA Visiting Research Fellowship will be known in your name. UniSA will then match each philanthropic gift, 1:1, meaning two Fellows will have the opportunity to visit and two Fellowships will be known in your name.

It has never been more urgent to prioritise research for the solutions we seek

To answer the questions that keep us all up at night, we need to invest in research. We need to invest in the brightest minds who imagine the questions, test the possibilities and provide the answers.

This is why at UniSA, we have created the **UniSA Visiting Research Fellowships** scheme to bring the world's most talented minds and practitioners to Adelaide to work in partnership with our researchers, and with business and community.

By collaborating and combining their expertise, they will enhance their research and produce exceptional outcomes that will benefit us all.

This collaboration is an extraordinary opportunity for everyone involved:

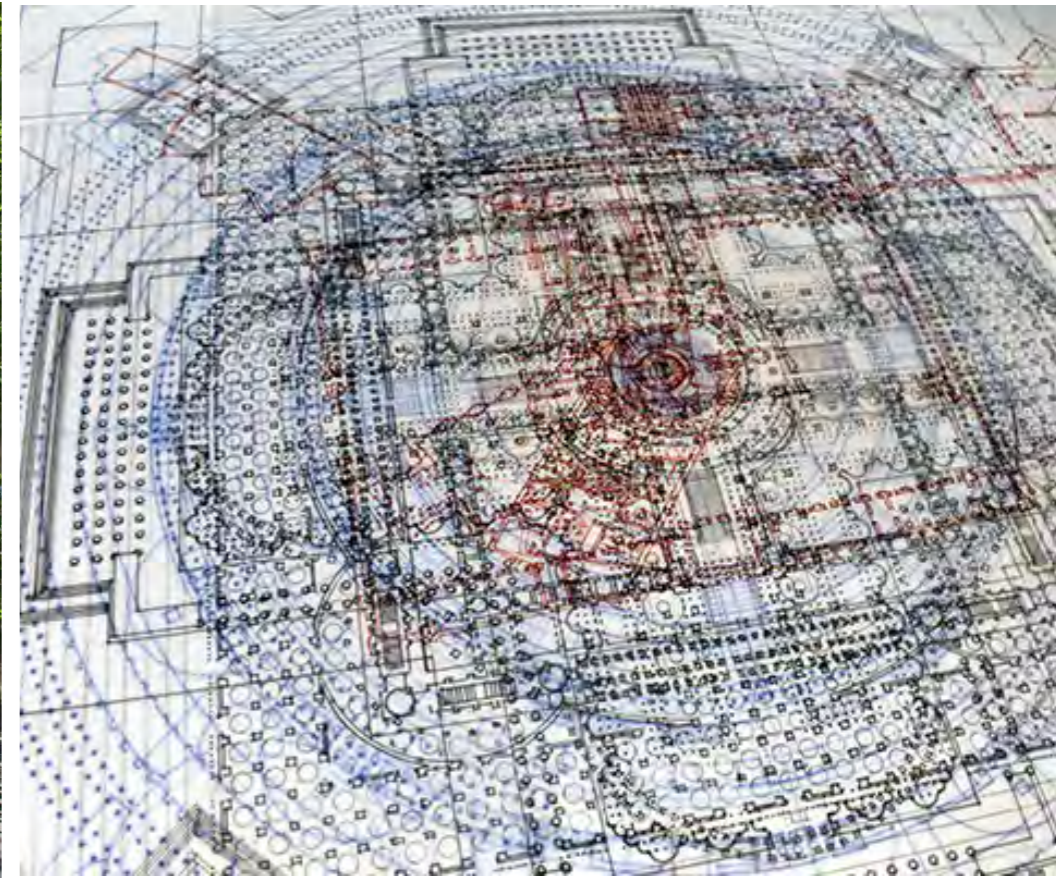
- ▶ For our researchers at UniSA to expand their networks and further their own work;

Tackling the big issues together

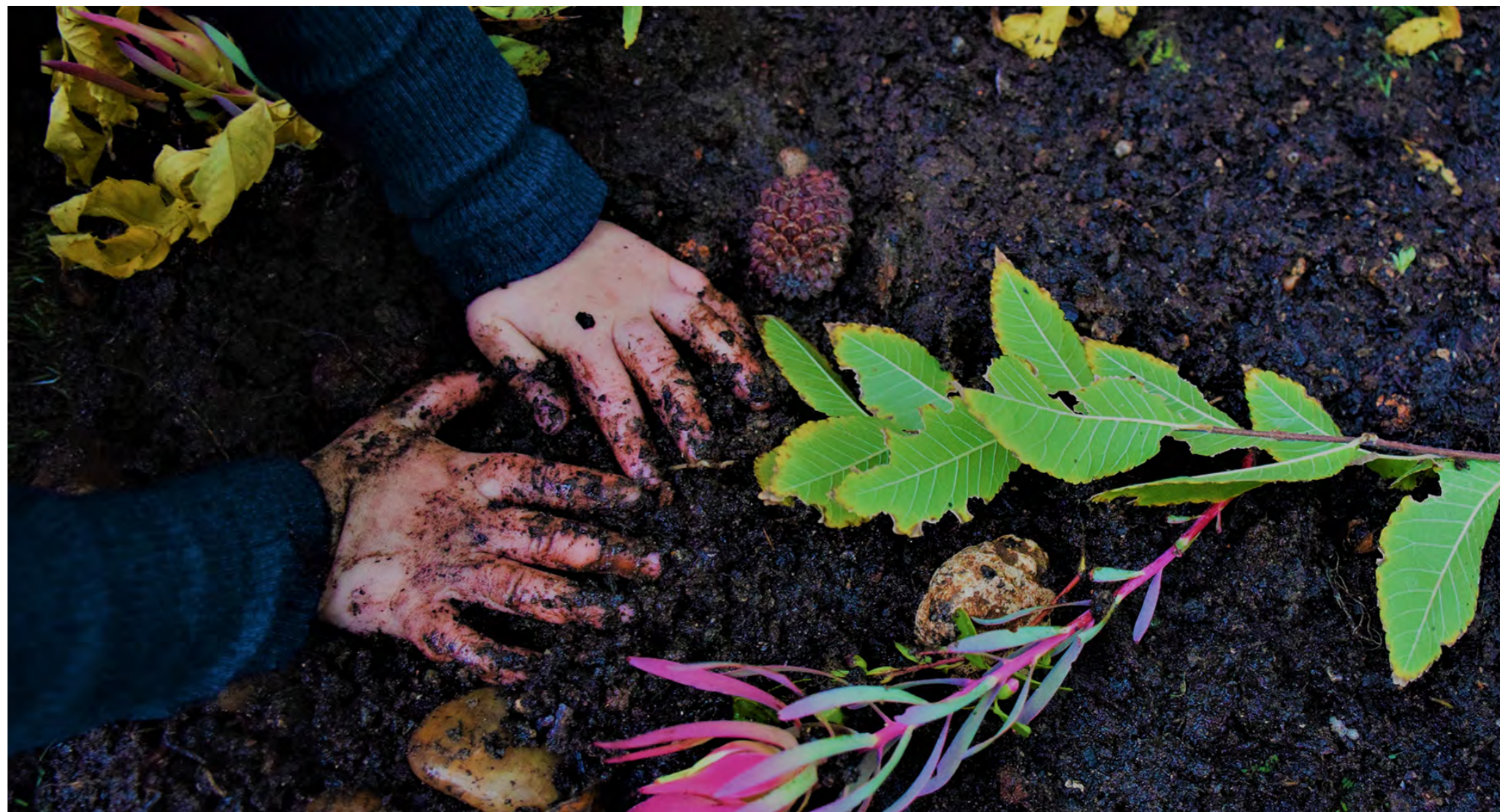
It is vital that we further our partnership with business and community to pursue the ideas and find the solutions that will bring about positive change. We want the world to be part of this too.

The Fellows will collaborate together on a vast range of issues - from COVID 19 to homelessness, economic equality to water security, and many more, such as:

- ▶ precision medicine;
- ▶ arts futures;
- ▶ technology and society;
- ▶ user-centred design;
- ▶ Aboriginal business development;
- ▶ older people and ageing well;
- ▶ gender and diversity in the workplace;
- ▶ mental health in the workplace; plus many more. .

With hundreds of Fellowships available, the breadth of research will be expansive.

Furthermore, it has been proven that when researchers co-publish with someone internationally in leading journals, the work is more likely to be cited and adopted. Think of this as world-leading change with South Australia signalled as its hub.





Ensuring inclusion and diversity

As part of these 500 Fellowships, there will be up to 25 positions each year that will be specifically available for researchers who identify as having Aboriginal or Torres Strait Islander, Indigenous or First Nation status, and from DFAT-aid recipient countries.

Aboriginal or Torres Strait Islander Visiting Research Fellowships

From foundation, UniSA has committed to being the University of Choice for Australian Aboriginal Peoples.

Our dedication to providing opportunities for those who identify as Aboriginal or Torres Strait Islander, Indigenous or First Nation status, will continue through this scheme. We believe in the power of Indigenous-led research, including lived and practice-based knowledges, and the benefits it provides for individuals to personally thrive and for communities to succeed as a whole.

This is part of our commitment to growing the community of Australian Aboriginal researchers, and supporting Indigenous and First-Nation led research globally.

DFAT-Aid Assisted Country Visiting Research Fellowships: collaboration with our Region and the World

Research is everyone's business, globally. By creating positions for research Fellows from DFAT-aid recipient countries, we are encouraging research that will drive innovation for business and community health and growth in our Region—the Indo-Pacific—and across the World. We will also benefit from the diversity of perspectives that we know can drive outstanding innovations.





How you can bring the World to UniSA, and take UniSA to the World

This scheme helps to put you in the driving seat for global change. When you make a commitment of \$15,000 per year x five years, the UniSA Visiting Research Fellowship will be known in your name and will highlight your fundamental support for innovation and progressing research.

The University will match this funding and will meet the costs of administering the scheme and access to our research facilities.

This initiative is your chance to benefit from the new knowledge explored by researchers concentrating on aligned topics of interest to you or your company. Anonymous gifts are also possible, if that is your wish too.

How you will benefit:

- ▶ Personally name the Visiting Research Fellowships;
- ▶ UniSA will then match each \$15,000 gift received, and two Fellowships will be known in your name;
- ▶ Have the unique opportunity to host the Fellowship recipients—some of the world's most exceptional talents—at a private function or speaking engagement;
- ▶ Your name will be included on all of the published papers generated during the visit;
- ▶ You will enjoy a reception at UniSA with the Fellowship recipients and UniSA Collaborators, hosted by UniSA;
- ▶ You have the opportunity to choose which research area you would like to support.

An additional benefit of this scheme is being able to showcase our best kept secret to the world, the somewhat hidden treasure, South Australia.

Our home will be on display and this scheme will help to grow our reputation internationally;

- ▶ We will be the focal point for the wealth of knowledge;
- ▶ We will house the outcomes;
- ▶ The researchers will return home and share their stories and memories of South Australia;
- ▶ By citing the University of South Australia in the published papers, we will be embedded in research history.

This scheme also allows UniSA to demonstrate the incredible work already being explored by our leading researchers, and the game-changing outcomes they have already discovered.

Economic benefits for South Australia

The UniSA Visiting Research Fellowship scheme will help to strengthen the State's recovering economy.

By bringing in hundreds of talented researchers to Adelaide for at least a month, we are generating local business and increasing revenue.

Importantly for the State's economy, the discoveries that are found as part of the UniSA Visiting Fellowship scheme have the real potential to lead to future investment from international businesses.

In return, the discoveries that are uncovered also have the potential to benefit local businesses that have a similar interest and aid with their future successes.

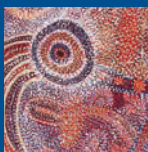
