Safety planning is an internationally recognised indicated suicide prevention strategy, involving the cocreation of a personalised list of strategies for those who experience onset or worsening suicidal ideation and/or behaviour to use during a suicidal crisis. The 13th Shared Learning in Clinical Practice Symposium will discuss and examine safety planning technique. Specifically, we will examine the origins and conceptual basis of safety planning alongside current practices and applications.

Speakers at today's symposium will also showcase their use of safety planning alongside the beliefs of why they work the way they do. Participants attending the symposium will also hear contributions from people with lived experience of using safety plans.
